
### Report on Feedback Analysis of Students – Academic Year 2019-2020

Himwant Kavi Chandra Kunwar Bartwal Rajkiya Mahavidhyalaya is committed towards academic and administrative excellence. The college has been dedicating continuous efforts towards improving and assessing itself on the basis of feedbacks received from students. The College implement suggestions thoroughly provided by the students after the analysis of the feedback survey.

#### Conclusions of the Feedback Analysis

- There were five questions asked regarding feedback survey of classes and syllabus in the feedback form. Maximum percentage of respondent that is 38% responds excellent regarding the Syllabus covered in the class by the faculty and sufficient books and reference material availability in the library. 12 % respondent responds unsatisfactory regarding the course content encouragement towards extra learning /self learning.
- There were seven question asked in the feedback survey regarding teaching. Maximum percentage of respondent that is 60% and 54% responds excellent regarding the teacher uses ICT tools and teacher encouragement to participate in extracurricular, sports, and cultural events respectively. Among the unsatisfactory responses maximum 6 % respondent were unsatisfied towards detail explanation of the topic by the teachers.
- Total ten questions were asked in the feedback survey regarding the infrastructural facilities of the college. 58% respondent responds excellent regarding the behaviour of the administrative employee. Among the unsatisfactory responses maximum 16 % respondent were unsatisfied towards availability and condition of the poor condition of washroom and sanitation.

After collecting and analyzing feedback from all stakeholders the following valuable suggestions were considered and necessary actions were taken.


#### SUGGESTIONS
